An association of synagogues and other religious, education, fraternal and community organizations, the Northeast Queens Jewish Community Council (NEQJCC) covers Bay Terrace, Bayside, Bellerose, Douglaston, Floral Park, Fresh Meadows, Glen Oaks, Hillcrest, Holliswood, Hollis Hills, Jamaica Estates, Little Neck, New Hyde Park, Oakland Gardens and Queens Village (north).

A beneficiary of UJA-Federation, the NEQJCC works closely with the Metropolitan Council on Jewish Poverty ("Met Council"), Samuel Field/Bay Terrace Y, Parker Jewish Institute for Health Care and Rehabilitation ("Parker"), Queens Region-Hadassah and Jewish Community Relations Council of Greater New York ("JCRC").

NEQJCC projects include maintaining a community calendar, neighborhood development, Jewish continuity including Shalom Bayit/Healthy Marriage, Lay Leadership, social action, promoting involvement and volunteer opportunities, fostering intergroup understanding and building a multi-cultural coalition. The Council combats anti-Semitism and discrimination, sponsors forums with major public figures, Jewish cultural events, open discussions with local Rabbis and represents community concerns. Its newest program, the *Harmony Initiative* or "*Hi*" represents a collaboration funded by the City Council, State Senate and Assembly including the Office of the Queens District Attorney, the City Commission on Human Rights and the Northeast Queens Branch-NAACP.

The Council helped form the NORC-WOW, a pilot program to serve seniors in one and two family homes. The Council publishes a (four-fold, 8.5 by 14-inch) brochure, *You Can Have It All*, touting life in northeast Queens communities, also available through its website.

Annual programs include its Installation of Officers and Awards Reception (sponsored by each fall by Parker), the lighting of the largest Chanukah Menorahs in Queens, *Hi* Pre-Passover and Fall Food Drives, Toy Drives and Coat Drives sponsored by the Y, Parker Jewish Institute for Health Care and Rehabilitation and Met Council, and a Purim Carnival at the Y.

Each Spring, the Council holds its Annual Legislative Forum, co-sponsored by Parker, Met Council, JCRC and Queens Hadassah, at the Y. In 2002, 2004 and 2008, the Council, together with Queens Hadassah, hosted the Ben Yeduda Street Comes to Bayside, an Israeli Gifts Fair, which attracted thousands of visitors who purchased direct from Israeli merchants.

## **Hon. Barbara Clark**

Elected to the New York State Assembly in November 1986, Barbara M. Clark represents the communities of Bellerose, Cambria Heights, Hollis, Queens Village, St. Albans, and part of Floral Park in the 33rd Assembly District. During her tenure, she has been a tireless, effective advocate for the needs of children, families, and the elderly. She has been a leader in education reform, day care and community development. A self-described "public servant," Assemblywoman Clark is readily accessible to her constituents. She devotes much of her time to creating institutions, policies, and programs that foster stability and growth. One such creation: converting the large, struggling Andrew Jackson High School into an impressive and progressive campus of four small magnet high schools.

Assemblywoman Clark, having been an active parent of four children who graduated from NYC public schools, is a leading advocate for parents having a statutory role in education policymaking. She was a primary sponsor of the 1996 School Governance Law, which mandates parental involvement in decisionmaking.

An active supporter of the Campaign for Fiscal Equity (CFE) lawsuit against the New York State, she has been unrelenting in her battle to change the State's inadequate and inequitable school finance system. In January 2001, State Supreme Justice Leland DeGrasse ruled, and the Court of Appeals affirmed, New York's school finance system as discriminatory and unconstitutional. Assemblywoman Clark was the only state legislator to testify at the trial.

Assemblywoman Clark has held a number of leadership positions in the State Legislature. She chaired Assembly Standing Committees on Aging, State and Federal Relations and the NYS Legislative Women's Caucus, a bipartisan organization of women legislators from both the Senate and the Assembly. She is presently the Chair of the Education Committee of the Black, Puerto Rican and Hispanic Caucus, a member of the Majority Steering Committee, and Assistant Majority Whip. Her current committee service includes Children and Families; Education; Labor; and Libraries & Education Technology. She has also sponsored significant pieces of legislation on education, health and consumer fraud.

Nationally, Assemblywoman Clark served as Vice-Chair of the National Conference of State Legislators' Education, Labor and Job Training Committee, and member of its Human Services Committee. As a member of the Education Partners, a public policy group of the National Conference of State Legislators, she assists state legislators and other policymakers throughout the country in making decisions about education policy, particularly in the area of finance.

Assemblywoman Clark, a coal miner's and health care administrator's daughter, was born in Beckley, West Virginia. She and her husband, Thomas Clark, Jr., have four adult children, Jan, Crystal, Thomas III, and Brian, and two granddaughters, Taylor and Lauren.

## **William Frumkin**

William Frumkin started his accounting career in 1963 in private accounting working for a multinational company. After switching to public accounting in 1970 he found a firm that piqued his interest. In 1981 he became a shareholder of that firm, which after two mergers, evolved into Frumkin, Lukin, & Zaidman, CPA's P.C.

He has developed expertise in the areas of real estate developers, construction contractors, wholesalers, retailers, and manufacturers, medical and legal field. Additionally, he specializes in business consulting with small businesses and individuals.



Bill brings his expertise to his nonprofit activities as well. He is the former president of the Samuel Field Y and continues to be a vocal board member serving as its Chairman of the Board. There he provided the impetus in the agency's acquisition of Camp Poyntelle/Lewis Village. In addition, Bill is a member of the Network Commission's Organizational Review Committee and the Task Force on Agency Capacity and Excellence.

He received a BA from Queens College, and has also completed graduate courses at Baruch College.

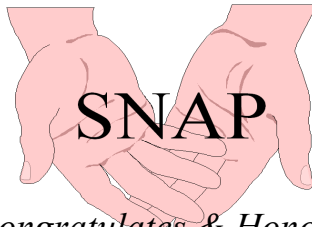

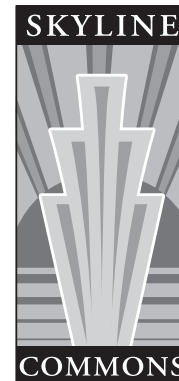

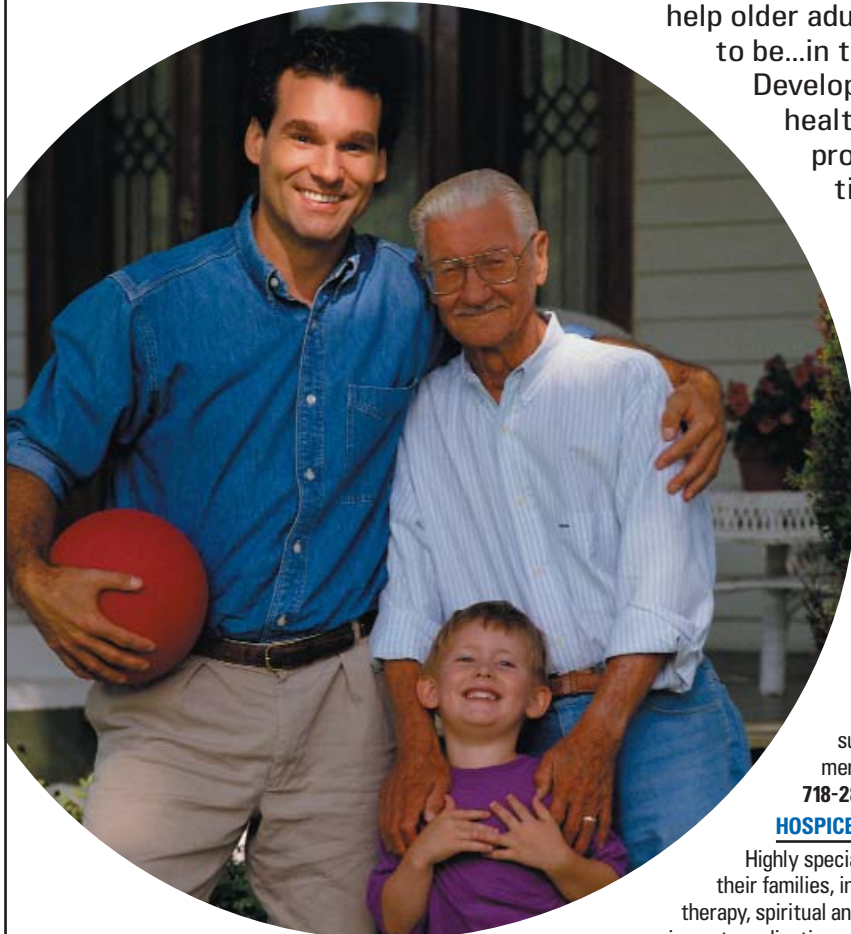
